The role of urban mobility transitions in sustainable futures

Call for papers for the thematic session of Cluster 4 – Urban Mobility Transitions

Nectar Cluster 4 has a focus on mobility transitions such as micromobility, shared mobility, vehicle automation and their interplay with streetscape design, urban forms, mobility practices and sustainability. The emergence of the shared economy and shared mobility services has disrupted the transport sector, by decoupling vehicle ownership and usage. There exists an evolving demand for new shared modes, such as ride-sourcing, ride-pooling, bike-sharing, scooter-sharing, which are combined in either complementary and/or competing way with traditional transport modes to satisfy mobility needs. Several issues about the social, environmental and economic sustainability of these modes are still heated topics of debate and research for the academic literature and for practitioners and regulators around the world.

Submissions for the Nectar Cluster 4 thematic session include, but are not limited to, the following topics:

- Social effects of new shared modes
- Environmental effects of new shared modes
- Accessibility effects of new shared modes
- Vehicle automation and travel behavior
- Impact of new shared modes on public space
- New shared modes and urban forms
- Street experiments and mobility transitions
- Evidence of new mobility cultures among young generations

Deadline for abstract submission

The deadline for abstract submission is January 31, 2024. Abstracts (max. 500 words) should be submitted electronically, using the form available on the conference website and following the

Criteria for acceptance are scope, scientific quality, NECTAR membership and the possibility to fit the presentation in a coherent conference session. The number of participants of this thematic session will be limited to 8.
